Demonstration Scenario

The demonstration scenario is a simulation of a rupture in the hose during bunkering services of Costa Concordia cruise ship accosted in Golden Horn-Halic generating an oil spill estimated to 08 m³ that was released into the sea. The cruise port company were providing a pre-booming services tanks to this almost all the spilled oil remained contained into the boom of an oil spill due to rupture in the hose. There were small amount went out from the boom and the Tier 2 service company have been mobilized. Based on the modeling made immediately using Mekeslick, service company deployed their resources at Halic at the predetermined sensitive areas.
